SEA-FISHERIES (NORTH WESTERN WATERS LANDING
OBLIGATION) REGULATIONS 2016

I, SIMON COVENEY, Minister for Agriculture, Food and the Marine, in exercise of the powers conferred on me by sections 3 and 14 of the Sea-Fisheries and Maritime Jurisdiction Act 2006 (No. 8 of 2006) and the Sea Fisheries, Fore-shore and Dumping at Sea (Transfer of Departmental Administration and Ministerial Functions) Order 2007 (S.I. No. 707 of 2007) (as adapted by the Agriculture, Fisheries and Food (Alteration of Name of Department and Title of Minister) Order 2011 (S.I. No. 455 of 2011)), for the purpose of giving further effect to Article 15 of Regulation (EU) No 1380/2013 of the European Parliament and of the Council of 11 December 2013¹ and effect to Commission Delegated Regulation (EU) 2015/2438 of 12 October 2015² hereby make the following regulations:

1. (1) These Regulations may be cited as the Sea-Fisheries (North Western Waters Landing Obligation) Regulations 2016.

(2) These regulations shall cease to have effect on 31 December 2018.

2. In these Regulations—

“Council Regulation” means Regulation (EU) No 1380/2013 of the European Parliament and of the Council of 11 December 2013;

“Commission Regulation” means Commission Delegated Regulation (EU) 2015/2438 of 12 October 2015.

3. (1) The master of a sea fishing boat which appears on any list of vessels provided for under Article 4 of the Commission Regulation shall comply with Articles 15(1), (4), (8), (11) and (12) of the Council Regulation in respect of North Western waters.

(2) The master of a sea fishing boat referred to in paragraph (1) may not discard catches other than in accordance with Article 2 or Article 3 of the Commission Regulation.

These regulations cease to have effect on 31 December 2018.
